SD-042 Application to Extend / Reduce the Maximum Period of Apprenticeship

Reduction or extension of the maximum period of the Apprenticeship must be approved by the National Artisan Training Committee:

1. Reductions will generally be granted for skills, experience and educational qualifications acquired by apprentices prior to indenturing
2. Extensions will generally be granted for periods of compulsory military / police training in excess of 30 day per annum, sick leave in excess of 30 days per annum. Absence from work due to a disablement / disease compensable in terms of the Compensation for Occupational Inquiries and Disease Act, and suspension from work for disciplinary reasons.
