1. GENERAL SUBMISSION

- 1.1. RFQ proposals must reach CHIETA before the closing date and time as specified above and be emailed to procurement@chieta.org.za
- 1.2. RFQ proposal received after the closing date and time will not be considered and will be returned to bidder.
- 1.3. Bidders may not seek or obtain the assistance of employees CHIETA in the preparation of their proposal's responses.

2. PAYMENT

- 2.1. CHIETA will pay the Contractor the fees set out in the final contract according to the table of deliverables. No additional amounts will be payable by the CHIETA to the Contractor.
- 2.2. The invoice must be accompanied by supporting source document(s) containing detailed information, as CHIETA may require, for the purposes of establishing the specific nature, extent and quality of the services which were undertaken by the Contractor.
- 2.3. No payment will be made to the Contractor unless an original tax invoice complying with section 20 of the VAT Act No 89 of 1991, as amended, has been submitted to CHIETA.
- 2.4. Payment shall be made by bank transfer into the Contractor's back account normally 30 days after receipt of an acceptable, original, valid tax invoice. Money will only be transferred into a South African bank account (CHIETA will affect payment only on accounts verified and appear on Central Supplier Database.)
- 2.5. The Contractor shall be responsible for accounting to the appropriate authorities for its income tax, VAT or other moneys required to be paid in terms of the applicable law.

1. Background

The CHIETA would like to appoint a suitable subject matter expert (SME), trained to facilitate the development of occupational qualifications and skills programmes, to facilitate the development of the Explosives Manufacturing Plant Head Skills Programme (Curriculum Code: 900436-000-00-00).

2. Scope of work and expected delivery.

- Facilitate scoping and profiling meetings.
- Facilitate development of Knowledge and Application modules (Practical &/Workplace) for curriculum.
- Facilitate and compile Skills Programme document, Curriculum, QAS Document and QAS Addendum, as per QCTO and SAQA specifications.
- Complete all QCTO reports.
- Submission and presentation of all developed documents for QCTO pre-verification and verification meetings where applicable
- Submission of completed Skills Programme document, Curriculum, QAS document and QAS addendum, and reports as per QCTO and SAQA specifications and templates to the CHIETA for QCTO evaluation and registration on the NQF.
- Fully completed work means that QCTO has approved the developed occupational qualification(s) for registration by SAQA.

3. Administrative task

- The SME is expected to have stable internet connection or access for online meetings with stakeholders for the development process including engagement sessions with CHIETA DQP Team.
- The SME is expected to have all documents typed out on MICROSOFT word using latest QCTO templates.
- The CHIETA will facilitate arrangements for meetings and the distribution of documents to all relevant stakeholders.



4. Contract duration and expected delivery timelines

Recommended and appointed service provider will be appointed for a period from June 2024 to 31 March 2025.

5. Evaluation & Selection criteria

The CHIETA has set minimum standards (Gates) that bidders must meet to be considered. All quotations duly lodged as specified in the Request for Quotation will be examined to determine compliance with quotation requirements and conditions. Quotations with obvious deviations from the requirements/conditions will be eliminated from further consideration.

5.1. GATE 1 – Administrative Test

The CHIETA will conduct screening of mandatory documents to check whether bidders fully meet compliance requirements. - 5.2.1. Track record indicating at least 3 occupational qualification/skills programs successfully developed in line with QCTO processes and currently registered on the NQF. **(weight 40)**
- 5.2.2. At least three (3) relevant references letters listing occupational qualifications/skills programs including the development of the QAS addendum developed within the last 5 years. References must be contactable. **(weight 40)**
- 5.2.3. Related certifications/diploma- facilitator, assessor, moderator, ETDP certification. **(weight 10)**
- 5.2.4. Clear project plan, including methodology, deliverables, key role players, their expertise, experience and their roles in the project, timeframes, unit cost per deliverable and all-inclusive overall costs. **(weight 10)**

5.3. Gate 3: Price and Preference

The bidders that have successfully progressed through to Gate 1 & 2 will be evaluated in accordance with the **80/20** Preference Point System as contemplated in the Preferential Procurement Regulations 2022 where bidder with highest score on price and preference will be awarded. If appropriate, implied contract price adjustments will be made to the cost proposals of all remaining quotations.
